SJD Workshop Update - Joye

General Information Added to Marian's title, "Financial Assistant. Required now to have 2 board meetings a year.

Fees increase: Judging fees increased 2 ½%

Carpool elimination, No longer required, and may have to be geographically decided. It was decided to include the following statement in update to judges at Judges' Cup

"Although we've now been given the flexibility to drive individually, please remember that meet directors also have the flexibility to request specific judges to reduce mileage costs. If driving ourselves significantly increases costs to gyms, then we may find ourselves with less meet options overall." (Credit to Michelle for wording).

Emergency Action Plan - Joye

After facing emergency situations at meets, the absence of an Emergency Action Plan has been recognized. As meet officials traveling and working away from home, there is a need to maintain emergency contact information that is easily accessible to those with us should an emergency arise. The decision was made to distribute an ICE (In Case of Emergency) card to all members at Judges' Cup to be completed and added to judging bags.

Stephen Conwell and Michelle Donovan will design a card that will provide needed information while maintaining privacy.

- Positives: Significant interest from potential new judges (>35 in past year), gaining more judges than we lose, education resources beneficial (ex. Quizlet, practice tests)
- Areas for Improvement: Lack of formal mentoring program (judges will now be given option to request a mentor as interest has been variable in past), Low pass rate on written optional tests (will roll out variety of new ideas to target different learning styles including study guides/schedules, test-taking strategies, etc. with goal to increase engagement as well as personal accountability)
- Recertification Needs: Written practice tests by level, more practice judging online/in person opportunities, creation of study groups

2018 Recertification Plans - Joye/All

Discussed group study options with technology. Brevet/National testing with USAG congress. First-come first-serve registration with testing on Sunday morning. Earliest testing for other levels will be National Congress August 7-9. Retreat for Brevet/National will be June 9-10. Discussion on what to pay for judges and Cookie Batsche. Will need a proposal to USAG board for what they may contribute.
